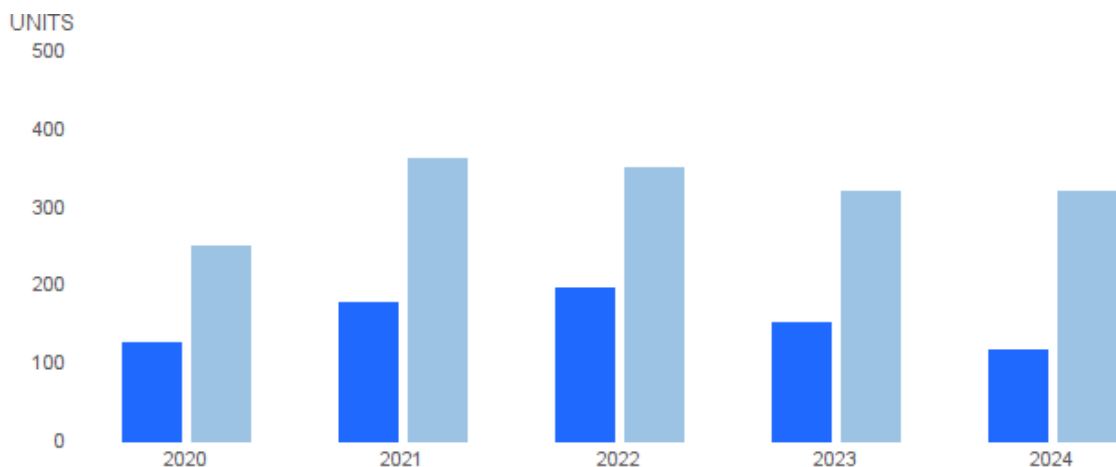

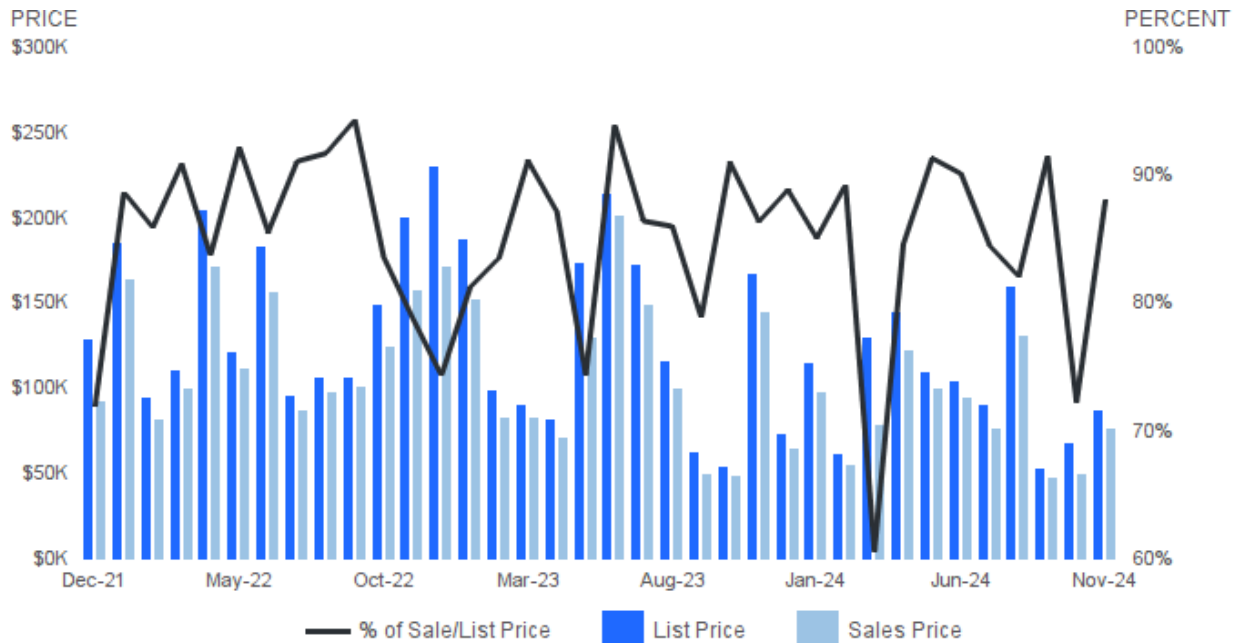

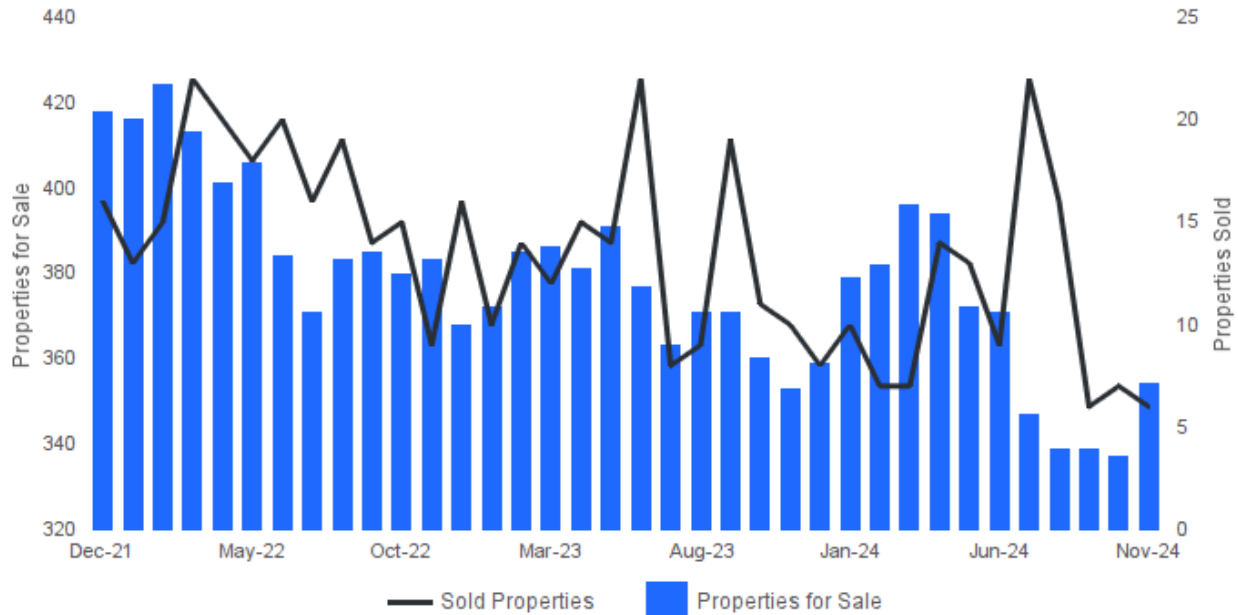

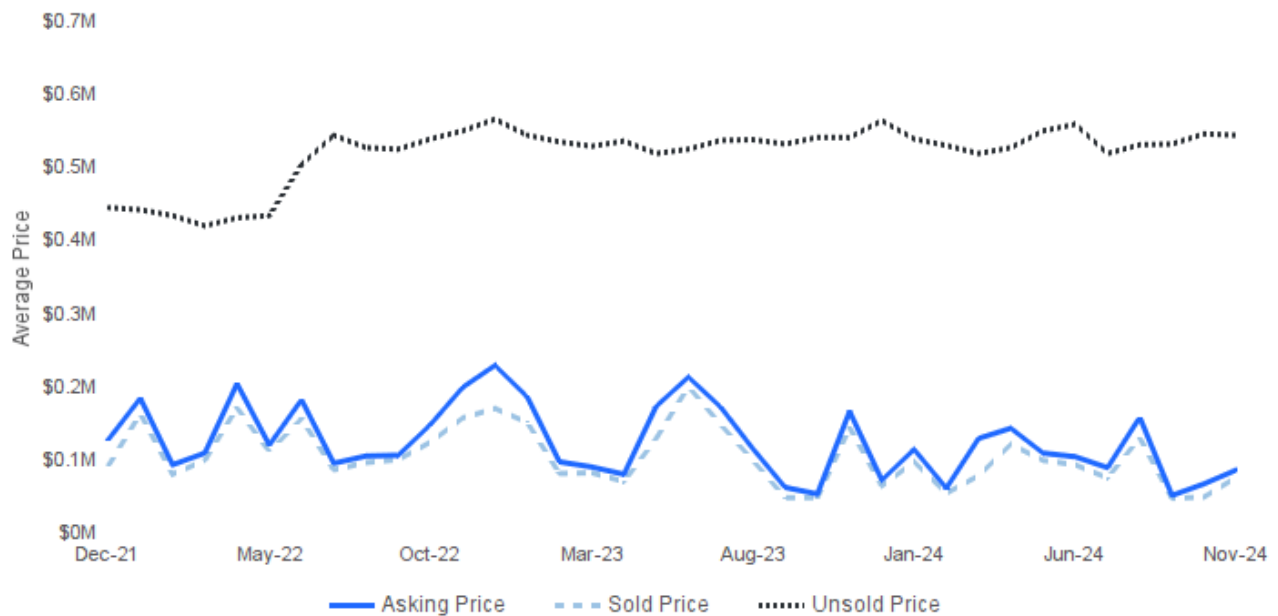

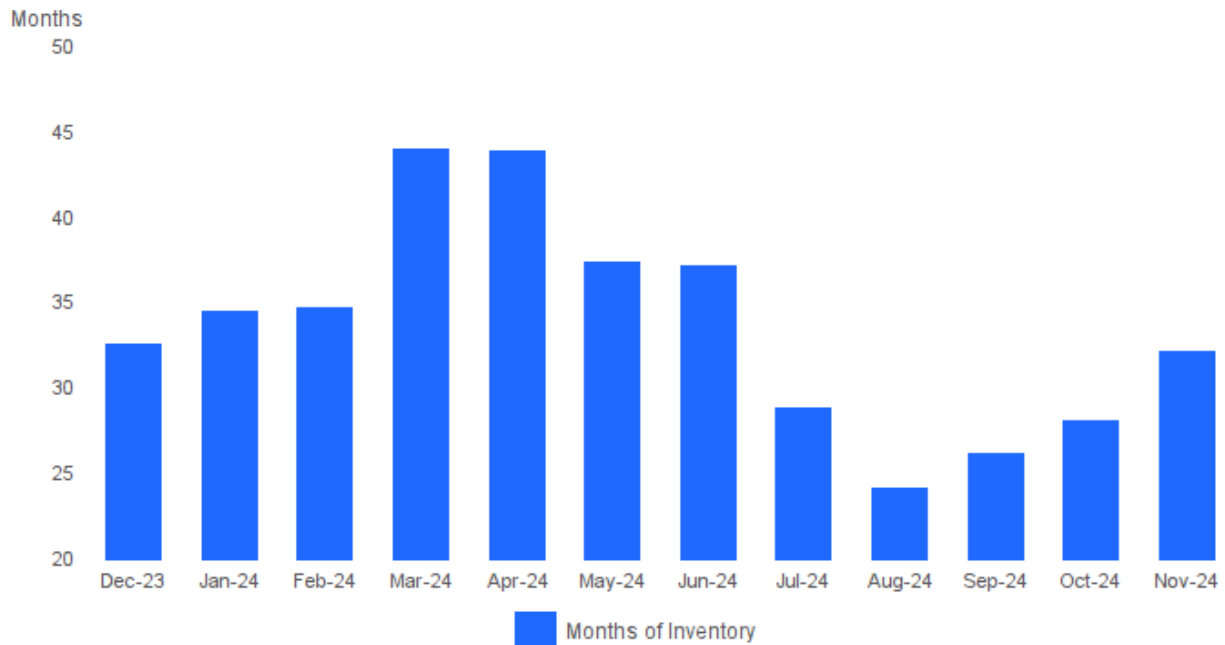
Asking Price | the average asking price of sold properties

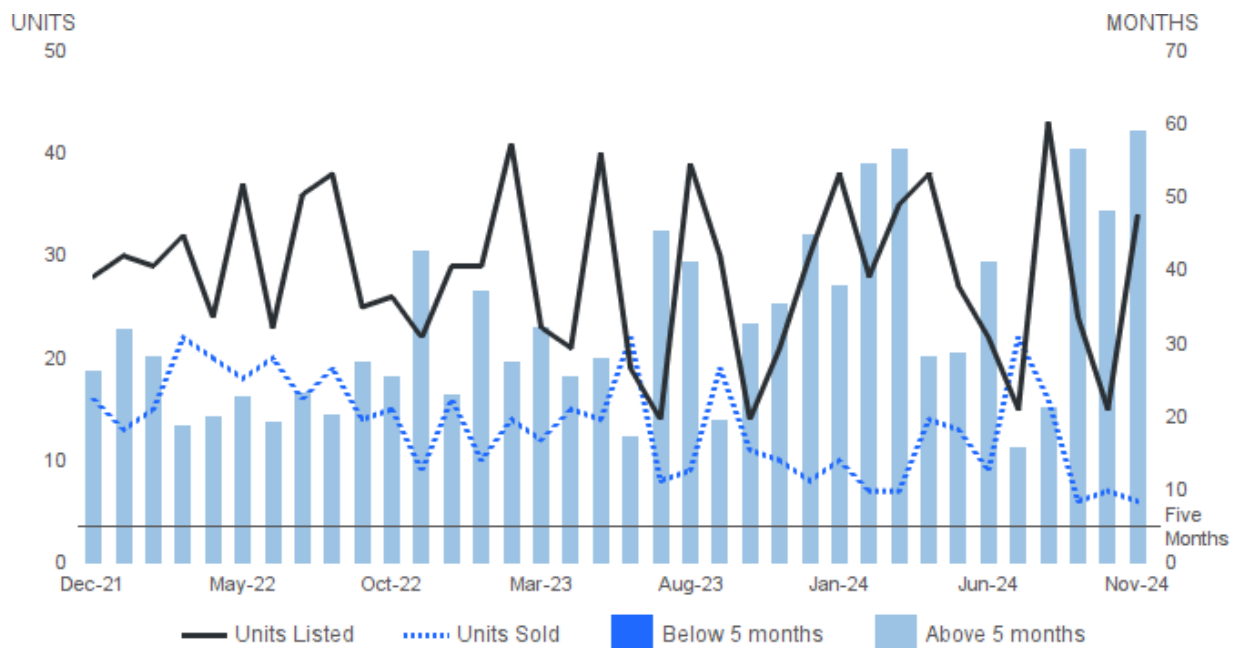
